We will strive for continuous improvement, and effectively manage our activities through the measures that include:

Environmental:

- ▶ Minimize the generation of emission streams and ensure its proper disposal;
- ▶ Manage Coal Processing Plant (CPP) materials, process rock and overburden appropriately;
- ▶ Implement measures to conserve natural resources such as energy, supplies, and water;
- ▶ Implement measures to reduce emissions to air, water, land, and to minimize our footprint;
- ▶ Implement measures to reduce our greenhouse gas emissions related to the Project;
- ▶ Integrate biodiversity conservation and land use planning considerations through all stages of business and production activities; and
- ▶ Progressively reclaim the Minesite to ensure physical and chemical stability in consultation with the communities in a timely manner.

Social:

- ▶ Maintain relationships with the Wet'suwet'en through implementation of the Socio-economic Management Plan (SEMP) and its Community Engagement Programs, including acknowledgement of the National Inquiry into Missing and Murdered Indigenous Women and Girls (MMIWG), Truth and Reconciliation Commission (TRC), and United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP); and
- ▶ Maintain communications with the community, also through implementation of the SEMP and its Community Engagement Programs.

Governance:

- ▶ Implement and maintain an effective EMS (planning, communication, checking, reporting, and reviewing) to monitor environmental performance;
